SUMMARY ANNUAL REPORT

FOR SANTA MONICA UNITE HERE HEALTH BENEFIT PLAN

This is a summary of the annual report of the Santa Monica UNITE HERE Health Benefit Plan, E.I.N. 95-6035138, Plan No. 501, for the year ended December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with United Concordia Dental Plans of California, Inc., Kaiser Foundation Health Plan, Inc., Beacon Health Options Inc., HealthNet Inc., and Delta Dental of California to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended December 31, 2022 was \$92,085,436.

Costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ended December 31, 2022, the premiums paid under such "experience-rated" contracts were \$546,278 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$176,951.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$89,040,417 as of December 31, 2022, compared to \$65,117,788 as of January 1, 2022. During the plan year, the plan experienced an increase in its net assets of \$23,922,629. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$126,586,801 including employer contributions of \$133,072,536, participant contributions of \$1,114,501, loss from investments of \$7,601,932, and other income \$1,696.

Plan expenses were \$102,664,172. These expenses included \$3,160,249 in administrative expenses and \$99,503,923 in benefits paid to or for participants and beneficiaries.
